



**Three Calls for Proposals for Partnership Development Activities  
Between Canada and India in ICT, Photonics, Nanotechnology, Biotechnology, Energy,  
Environment and Aerospace  
Deadline: August 3, 2010; 12 Midnight EST**

International Science and Technology Partnerships Canada (ISTPCanada), the Department of Science and Technology (DST)/ Global Innovation and Technology Alliance or GITA (India), and the Department of Biotechnology or DBT (India) are hosting three Calls for Proposals (CFP) for Partnership Development Activities (PDAs) between Canada and India.

The Calls invite *university researchers, technology experts and industry leaders* to propose PDAs that will help forge new research and technology development partnerships between Canadian and Indian innovators, and stimulate R&D or business collaboration that increases the competitiveness of both countries.

Leveraging investment from the Governments of Canada and India, these program delivery agencies will support dozens of new bilateral PDAs that span multiple technology areas such as photonics, nanotechnology/nanoscience; and industrial sectors such as information and communications technologies (ICT), life sciences, energy, environment, earth sciences and aerospace. **Canadian and Indian funding recipients are eligible to receive up to a maximum of CDN \$25,000 (or the equivalent value in Rupees) for their PDA.**

Complete applications are required by **August 3, 2010, Midnight EST**. Selected PDAs will be announced in **September 2010**, and must be completed by **February 15, 2011**.

**Selecting the Right Canada-India CFP for You**

*Eligible Canadian university researchers and companies are invited to apply to any of the three Canada-India PDA CFPs.* Representatives from Agencies of the Crown (including crown corporations, government laboratories and institutes etc.) are eligible *to participate* in PDAs, however they are not eligible to receive funding or subsidies from ISTPCanada.

PDAs bring together university researchers, technology developers, industry leaders, subject matter experts and other stakeholders from a minimum of two jurisdictions to explore novel models of R&D collaboration, and innovative ways to work cooperatively on new technology advancements or solutions to the existing problems. They may take the form of scientific seminars, conferences, symposia and workshops, as well as other joint initiatives that involve exchanges among scientists, experts, industry participants and academics. These initiatives aim to help participants become more competitive by developing global research-based alliances with the potential to foster increased international R&D or business collaboration.
